An affidavit is a statement of facts made in writing, which is confirmed by the oath or affirmation of the person making it before someone with the authority to administer an oath or affirmation.

1.0 Affidavit without Exhibits

1.1 Affidavit Content Requirements

Requirement	Instructions	Completed
Affidavit	 Include the following: (a) Deponent statement – you have to identify yourself as the person who is making the statements in the affidavit. (b) Knowledge Statement – you state whether you are the appellant or respondent and that you have personal knowledge of the information and facts that you are putting in the affidavit. (c) Body of affidavit. Simple, organized and short relevant facts. 	
Affirmation	 You must swear your affidavit in front of a lawyer or a commissioner for taking affidavits. A court official such as a registry clerk is a commissioner for taking affidavits. If a person swears or affirms an affidavit before another person by video conference, the affidavit must state that the person swearing or affirming the affidavit was not physically present before the other person, but was before that person by video conference. Requires signature.

2.1 Affidavit Content Requirements

Optional: Exhibits	You may attach/combine letters or other important documents you want the judge to consider. These are exhibits to the affidavit. If exhibits are combined with the affidavit, the exhibit must have this information: This exhibit [enter letter or number] referred to in the affidavit of [enter name] sworn (affirmed) before me this [enter day] day of [enter month, year] at [enter City/Town/Province/State/Country] Or A lawyer or a commissioner can affix an exhibit stamp to fill in the above information.

2.2 Affidavit Format and Technical Requirements

This checklist of all requirements for combining multiple files into one PDF (eBook or portfolio) requires a PDF tool. <u>Please see technical instructions</u>

Requirement	Instructions	Completed
True Copies	Must be an identical or true copy of the original document whether that original is scanned from paper or saved into PDF from another program, such as Microsoft Word.	
Scanned Records: Optical Character Recognized – OCR DPI - 300	If scanning is necessary because the original text-based document is paper or requires a handwritten signature, the scan must be Optical Character Recognized (OCR'ed) with a minimum resolution setting of 300 DPI. This allows the PDF to be copied from and pasted into another document and allows text to be searchable.	
Page Numbering	 page numbered (1, 2, 3) sequentially top centre of the page can start on the title page Page searching <u>must</u> match page numbering (if page numbering starts after the title page this is done using the Page Labels function in Adobe otherwise page 1 will be the title page when searching – see <u>Technical Instructions</u>) 	
Bookmarking Bookmarks must be:	The combined files (documents) must also contain bookmarks, which consistently, meaningfully, and clearly describe the individual documents or sections of the book. For example, bookmarks should describe the contents of the Exhibit (e.g. "Exhibit 1 – June 1, 2019 - Letter from John to Jane Doe.")
