### APPLICATION PROCESS FOR CLERKSHIP POSITIONS IN THE 2026-2027 TERM

**Applications for Judicial Law Clerk Positions must be completed in accordance with the instructions below.**

**Applications that do not include the questionnaire submitted through the BC Public Service Job Opportunity website will *not* be accepted.**

#### **Application Deadline**

Applications for judicial law clerk positions for the 2026-2027 term will be accepted from January 6, 2025 until January 20, 2025 at 11:00 am (PST).

#### **Application Requirements**

Review the detailed application requirements outlined below (and in the Position Posting). Your application must include the items listed below and must be submitted in the manner described.

- 1. A completed online questionnaire via the BC Public Service Job Opportunity website**

IMPORTANT: The online questionnaire on the BC Public Service Job Opportunity website is very short, but it cannot be saved and will time out after 60 minutes. You will need to complete the questionnaire and submit it within 60 minutes or you will lose any information you have entered. Further instructions are provided in the questionnaire. Note that there are character limits in each field and your answers should be brief.

- 2. A cover letter (submitted via email)**

- 3. A resume (submitted via email)**

**4. Copies of all official transcripts from law school, undergraduate, and postgraduate studies scanned into one high resolution PDF (submitted via email)**

- Copies of official transcripts from your undergraduate, postgraduate, and law school studies must be provided by the January 20<sup>th</sup> deadline. If your fall term law grades are not available on your official transcript by the deadline, you may submit an unofficial transcript instead. If your fall term law grades have not been released by the application deadline, you must note that in your email and submit them as soon as possible.
- Documents listed in items 2 to 4 above must be emailed to [judiciallawclerkprogram@bccourts.ca](mailto:judiciallawclerkprogram@bccourts.ca) following the instructions below or your application may be rejected.
- Email your: (1) cover letter, (2) resume, and (3) transcripts, as individual pdf files attached to a SINGLE email.
- ALL emails sent regarding your application must include a subject line and a signature in the format below:

**5. Two reference letters must be sent by referees by email directly to [judiciallawclerkprogram@bccourts.ca](mailto:judiciallawclerkprogram@bccourts.ca) by Monday, January 20, 2025 at 11:00 am (PST)**

- Ensure that you email your referee a link to the [guidelines](#) for submitting a letter of reference. Letters must be sent individually with the student's name in the subject line.
- At least one of your two referees must be a law professor.
- DO NOT MAIL letters of reference. Only emailed letters of reference will be accepted. Again, please ensure your referee is aware of and follows the [guidelines](#).

## **Interviews**

**First Round of Interviews: January 29 – February 7, 2025**

Applicants selected for a first interview will be interviewed by the courts' legal counsel during the period of **January 29 – February 7, 2025**. All interviews will be conducted by video conference. You will also be asked to complete a short writing assignment. Not all applicants will be interviewed, but all will be contacted.

## **Second Round of Interviews: March 3 – 14, 2025**

A second round of interviews for those applicants shortlisted after the first round will take place during the week of **March 3 to 7, 2025** for the Court of Appeal, and **March 10 to 14, 2025** for the Supreme Court. Second-round interviews are conducted by a panel of judges from either the Court of Appeal or the Supreme Court. If you have a preference for a position at the Court of Appeal or at the Supreme Court, you may indicate that in your cover letter and in the application questionnaire. In some limited circumstances a candidate who interviews with judges of the Court of Appeal and is not offered a position may be offered the opportunity to interview with judges of the Supreme Court. All interviews will be conducted by video conference.
