

FORM 2: MEDIA REQUEST FOR ACCESS TO AN EXHIBIT (REQUEST FOR AN EXHIBIT WHERE NO EXHIBIT ACCESS PROTOCOL HAS BEEN IMPLEMENTED)

FORM 2 is available on the Supreme Court of British Columbia website for accredited members of the media to utilize in criminal or civil proceedings where no exhibit access protocol is in place, but one or more members of the accredited media wishes to request access to a particular exhibit (or group of exhibits).

The purpose of FORM 2 is to minimize the need for accredited media to make formal court applications for access to an exhibit where the request for access may appropriately be addressed on an expeditious basis.

An accredited member of the media (THE INITIAL APPLICANT) completes section A and submits FORM 2 in its entirety to the Registry where the proceedings are underway or to the court clerk in the courtroom where the proceedings are underway. The Registry or the court clerk ensures that the presiding judge receives the form. The presiding judge then considers the request and makes a determination about:

- 1. whether access can be granted and on what terms;
- 2. whether input from the parties is required either via oral submissions or by completion of section B; or
- 3. whether a formal application for access with in-person submissions from counsel, self-represented parties, or third parties (with an apparent or potential interest in the subject matter of the application) is necessary.
